Head Start is a comprehensive family program for income eligible preschool children and their families. For a successful Head Start program, parent and community involvement is key. Head Start's performance standards are divided into three sections:

- Early Childhood Development
- Family and Community Partnerships
- Program Design and Management

Three and four year old children and their families receive services in:

- Education
- Parent Involvement
- Disabilities
- Nutrition
- Transition
- Literacy
- Health
- Family Services
- Mental Health

Head Start encourages family literacy and other education opportunities that may include:

- Pursuing a GED
- English as a Second Language
- Adult basic education
- Higher education opportunities

Head Start has both home and center-based options:

- Home-Based: Uses the family's home as the learning environment; Services are delivered through the combination of weekly home visits, group socialization activities, and parent education.
- Center-Based: Uses the classroom as the learning environment; services are delivered through preschool education (a.m. and p.m. sessions, and full-day, full year), initial and mid-year home visits, parent/staff goal setting conferences, and educational family connection events
