STATEMENT REGARDING LAWFUL PURPOSE EXPENDITURE

Community Action Partnership of Mid-Nebraska is engaged in pull-tab (pickle card) activity as a licensed tax-exempt organization under the Nebraska pickle card statutes. Under Nebraska law only tax-exempt, non-profit organizations may be licensed pickle card organizations. All net profits of the organization from the pickle card (pull-tab) activities are required by the Nebraska Pickle Card Statutes to be used by or donated by the organization for exempt purposes. In calculating unrelated business taxable income, the taxpayer is claiming a §162 ordinary and necessary business expense for the State statutorily-mandated lawful purpose expenditures paid from gross gambling proceeds. The §162 deduction claimed on the taxpayer's 2015 Form 990-T for self-paid lawful purpose expenditures is \$6,040.
