Organization uses volunteer labor to operate Pickles and Bingo activities from which the net proceeds are donated to support Community Action Partnership of Mid-Nebraska, Inc. services - The Lincoln County Senior Service Center. It is the opinion of the organization that Bingo proceeds which constituted \$10,595 do not represent Unrelated Business Taxable Income and/or a deduction is allowable offsetting the income because the net proceeds are paid over to an exempt organization (i.e. a lawful purpose expenditure).

Under Nebraska law only tax-exempt, non-profit organizations may be licensed pickle card organizations. All net profits of the organization from the pickle card (pull-tab) activities are required by the Nebraska Pickle Card Statutes to be used by or donated by the organization for exempt purposes. In calculating unrelated business taxable income, the taxpayer is claiming a §162 ordinary and necessary business expense for the State statutorily-mandated lawful purpose expenditures paid from gross gambling proceeds. The §162 deduction claimed on the taxpayer's 2016 Form 990-T for self-paid lawful purpose expenditures is \$834.
